1. INTRODUCTION

The Department of Public Enterprises is the shareholder representative on behalf of Government with oversight responsibility over six State Owned Enterprises (SOEs) that operate in core sectors of the economy like Mining, Defence, Energy, Logistics, and others. The SOE's in the Department's portfolio are namely: Eskom, Transnet, Denel, South African Airways, SA Express Airways, SAFCOL and Alexkor.

2. TERMS OF REFERENCE / SCOPE OF WORK

The Department invites experienced and reputable service providers to submit quotations for website and intranet maintenance and hosting. This will be for a period of two (2) years as per the following specifications. However, the service provider will have to undergo an annual service review process to continue rendering services for the next year of contract.

3. DELIVERABLES

- The service provider must have a minimum experience of three (3) years in hosting and maintenance of websites, intranets, web-based applications, systems and processes in Information and Communications Technology related fields.
- Familiarity and relevant experience in using Content Management System, particularly WordPress.
- Have excellent knowledge of recent trends in graphic design, websites, including social media networking.
- The company must have a proven track record in the ICT sector, which includes testimonials and references from previous companies where services were rendered.
- The personnel of the service provider must have an ICT or Web Design related qualification from a recognised institution of higher learning.
- The Department's current website and intranet are built on a custom framework using PHP technology, MySQL database and WordPress CMS. The appointed service provider should be able to migrate the website and intranet from the current service provider' platforms to their platform in order to successfully host and maintain the DPE website and intranet without any challenges and downtime.

4. PROJECT DURATION

The project's duration is for a period of two (2) years (24 months) , and the Department reserves the right to assess and review the performance of the service provider and to terminate the contract due to non- performance.

5. EVALUATION CRITERIA

In order to facilitate a transparent selection process that allows equal opportunity to all bidders, DPE has a Supply Chain Management policy that will be adhered to. Proposals will be evaluated in terms of the prevailing Supply Chain Management policy applicable to DPE and it should be noted that proposals will be evaluated in two (2) phases namely, Mandatory evaluation and Price estimated to **(R1000 000)** and B-BBEE using the 80/20 formula (preference points system) as per the PPPFA 2017 Regulations.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

- 4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

- 5 In order to give effect to the above, the attached Certificate of Bid Determination (SBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
